- The second report contains the completed checklist for each spill kit and an individualized list of components replaced.
- Emergency re-stocks available for dispatch within 24 hours.
- All inspected spill kits are fitted with a tamper evident audit tag
- Training tools supplied as required, ensuring that even new staff can effectively respond to hazardous spills.
